## **NIH Compliance**

For NIH-funded research, the publications need to be in compliance with the **NIH Public Access Policy**: <a href="https://publicaccess.nih.gov/">https://publicaccess.nih.gov/</a> and <a href="https://seo.sfsu.edu/conferences-travel">https://seo.sfsu.edu/conferences-travel</a>.

Many science literature publishers automatically comply with the policy: "Final, peer-reviewed manuscripts must be submitted to the NIH Manuscript Submission System (NIHMS) upon acceptance for publication, and be made publicly available on PMC no later than 12 months after the official date of publication." NIH research funded papers need to have a **PMCID**.

However, some publishers do not automatically comply with the NIH policy by making the paper available on the PMC website: <a href="http://www.ncbi.nlm.nih.gov/pmc/about/submission-methods/">http://www.ncbi.nlm.nih.gov/pmc/about/submission-methods/</a> and <a href="http://www.ncbi.nlm.nih.gov/books/NBK3846/">http://www.ncbi.nlm.nih.gov/books/NBK3846/</a>. In this case, the first author or the lead faculty mentor needs to do extra steps with the publisher to comply with the NIH Public Access Policy.

If we do not comply with this policy, NIH funding can be held up until we are in compliance. If you need help with this process, let us know.
